FACILITY DIRECTIONS

FROM THE WEST

Take I-40 East/I-85 North toward Raleigh and Durham. Take I-40 toward Raleigh when it splits from I-85 and proceed to Chapel Hill exit 273. Turn right onto Hwy 54 West/Raleigh Road at the top of the ramp. From this point, it is 3.4 miles to our parking lot. Drive toward campus past the Friday Center on the left and under the overpass for Hwy 15/501 and 54-Bypass. Continue up the hill, go through the intersection with Country Club Road, and turn left into the parking lot next to the Knapp-Sanders Building.

FROM THE EAST:

Take I-40 West to Chapel Hill exit 273 towards Chapel Hill. Exit ramp merges right onto Highway 54 West and crosses the overpass. From this point, it is 3.4 miles to our parking lot. Drive toward campus past the Friday Center on the left and under the overpass for Hwy 15/501 and 54 Bypass. Continue up the hill, go through the intersection with Country Club Road, and turn left into the parking lot next to the Knapp-Sanders Building.

Parking

Press the intercom call button to inform the receptionist that you are attending the NCHIMA meeting. Obtain your parking permit at registration and place it on your car dashboard. Parking permits must be displayed in your windshield while your car is in the lot to avoid a ticket or your car could be towed.
